<u>Program Description provided by the Applicant (from Executive Summary on Proposal</u> <u>Template):</u>

Ozark Rape Crisis Center, Inc. (ORCC), the nonprofit sexual assault and domestic violence prevention and response program for eight counties (Boone. Carroll, Johnson, Marion, Newton, Pope, Searcy, and Yell) stretching from the mid-Arkansas River Valley to the Missouri border in west-central Arkansas, seeks funding from the American Rescue Plan (through the Arkansas State Fiscal Recovery Funds (SFRF) Application process) as it works to address an increase in sexual assault and domestic violence resulting from the COVID-19 pandemic and exacerbated by severe, statewide funding cuts tied to the Victims of Crime Act (VOCA). This funding will bolster victim services coordination between law enforcement, judicial, healthcare, mental health care, human service, and community engagement programming, all critical to effective crisis response for victims of sexual assault and domestic violence, but which have been halted or slowed by the pandemic for an extended period. The funding will enhance sexual assault prevention programs that have been badly curtailed for children and young adults due to extended school closures. The total request is \$543,328.00 to be applied over five years. A detailed budget spreadsheet and narrative, and thorough COVID-19 crisis response plans are attached to this request. Third-party data and research citations are included as endnotes.

Eligible Per CTEH/Hagerty Review:

- ARPA offers support to specific community-based organizations to provide culturally specific activities for survivors of sexual assault and domestic violence, to address emergent needs exacerbated by the COVID-19 public health emergency.
- ARPA Interim Final rule defines as eligible programs which serve "Disproportionately Impacted Populations and Communities." These programs include community violence intervention programs, which are provided to populations disproportionately impacted by the COVID-19 public health emergency,
- The project addresses increased sexual assault and domestic violence resulting from the COVID-19 pandemic, as is common in natural disasters but now exacerbated by the COVID-19 stay-at-home orders. The program activities generally align to address the urgent needs of survivors of domestic violence, whose situations have been exacerbated by the pandemic.
- This program is therefore eligible.
