General Information

This guide contains the required electronic file formats needed to file motor fuel tax returns electronically. This guide is designed to provide the rules, procedures, and technical requirements for the electronic filing of motor fuel taxes. The purpose of this document is to facilitate the development of software for filing Motor Fuel Tax Returns using XML in the State of Arkansas. Inquiries about XML filing can be made via the email address MotorFuelTax@dfa.arkansas.gov.

Acceptable Electronic Formats and Transmission Methods

Arkansas is currently accepting Motor Fuel Tax returns through EDI submissions or through XML import on ATAP. Please see the EDI Implementation Guide for more information on EDI filing. Read on for documentation on XML returns.

Submitting XML Returns

Please see the Motor Fuel XML Upload and Implementation Guide for more information on how to import an XML return on ATAP.

Amended Returns

To amend a return, a new XML file may be imported (see MFT Upload Guide). Please note in the Amended Reason box on ATAP if the amendment is adding additional schedules, correcting existing schedules, or replacing the original return and provide details on the differences. Once the Motor Fuel Tax Department has reviewed these changes, they will appear in ATAP.

No Activity Returns

If there is no activity to report for a return type on a period (i.e. no activity on gasoline importer), then submit the XML return with a DistributorReport with just the ReportID and NoActivity marked as true.

Important Tips

- Report gallons of gasoline and aviation gas in the gasoline column
- Diesel fuel may include kerosene or jet fuel, but clear and dyed gallons should be reported in separate columns (Note: Dyed Diesel returns are filed separately)
- All fuel types reported should be identified by product codes on the appropriate schedule, round to whole gallons
- Round down all amounts less than 0.50 and round up all amounts of 0.50 through 0.99
- Decimal points are not valid in the gallon fields
- All fuel types can be reported on the same XML file
- Purchaser and Seller can not be reported on the same DistributorSchedule
- Please ensure that all the information on the tax return is correct before filing via XML
- Origin and Destination elements can only contain City/State information, not a terminal code

Populating XML Data Elements

Schema Validation

MFT submissions must be in a valid XML format as defined by the current schema set. Submissions that do not pass schema validation will be rejected. Schema validation includes the validation of appropriate Xpaths and individual element constraints.

Table Definitions

This guide contains the table layouts that are used to define how data elements should be populated using the current schema set. Each table contains one or more of the following columns:

Field Name

Combined with the Xpath associated with the table header, defines the full Xpath of the data element listed.

Complex Type

Defines a repeating section of information, such as a schedule on a report. These complex types are broken down further on the table and appear bolded.

Required

Denotes whether the element is required when the XML file is submitted. Required fields that are not filled out or are not filled out correctly will not pass the validation process.

Description

A brief description of the data element, the type of information it holds, and potential values that can be chosen for each element.
