Description: Geologic mapping of the Durham, Japton, Witter, and Weathers quadrangles, Northwest, Arkansas. The AGS proposes to map the Durham, Japton, Witter, and Weathers quadrangles (Fig. 3). Boyd Haley mapped the Durham and Japton quadrangles on the 15' base map and the Witter and Weathers quadrangles on a 7.5' base map using aerial photography circa 1972. This mapping was done to produce the 1:500,000-scale Geologic Map of Arkansas in 1976 and this area has not been re-mapped since that time. Detailed geologic mapping of this area will aid in source water protection around Beaver Lake which is drinking water source for Northwest Arkansas.
