Meeting Minutes Arkansas Medical Marijuana Commission

Chairwoman Tillman called the meeting to Order. Commissioners Russell, Smith and Mobley appeared by conference call and/or live stream. The minutes were previously provided to the Commission for review. Commissioner Russell made a motion to accept the minutes. It was seconded by Commissioner Smith and passed 4-0.

The next item on the agenda were the notice items. Director Chandler presented a change of floor plans by Permit 26 Bold and a name change by Permit 63 Arkansas Green Cross Cannabis to Spring River Dispensary. Commissioner Story joined the meeting via conference call. The Commission was next presented with a change of location request by Permit 198 Missco Cannabis Dispensary. The request was presented by Attorney Casey Castleberry. Attorney Erika Gee commented regarding the request and raised opposition to the request. Commissioner Story made a motion to deny the transfer of location. Commissioner Russell seconded the motion and it passed 4-1 (Commissioner Smith dissented).

A change of ownership by Permit 123 Natural State Wellness Enterprises was presented by Attorney Alex Gray and Ben Kimbro. After the presentation Commissioner Tillman made a motion to allow the change of ownership. The motion was seconded by Commissioner Russell and passed 5-0. Permit 123 next presented a change of location request. It was presented by Attorney Alex Gray. Commissioner Story made a motion to allow the transfer of location. It was seconded by Commissioner Smith and passed 5-0. It was noticed to the Commission that Permit 123 would be changing its name to Good Day Farm, LLC. The last change of ownership was requested by 126 Little Rock House of Cannabis. Attorney Alex Gray presented the request for change of ownership. Commissioner Smith made a motion to approve the transfer of ownership. It was seconded by Commissioner Mobley and passed 5-0. It was notice to the Commission that Permit 126 would be changing its name to Capital City Medicinals, LLC.

The last agenda item was an update on dispensaries. Director Chandler presented updated sales information along with patient count updates. Don Brewington spoke in favor of expanding the dispensaries in Zone 6 and addressed an increase in demand. Dragon Vicentic, owner of Green Springs, spoke against adding an additional dispensary in Zone 6. Senator Bill Sample spoke in favor of expanding the dispensaries in Zone 6 due to the upcoming dissolution of the reserve pool and based upon demand in the area. Commissioner Tillman asked the commission if they sought to revote on Zone 6 at the meeting. Commissioners Story, Mobley, and Russell voted against a revote and Commissioner Smith voted in favor of a revote regarding Zone 6.

The next meeting was set for December 8th, 4:30 p.m. and the meeting was adjourned.
