Under the provisions of 15 U.S.C. §§1681d(a)(1) and 1681g(c), applicants are entitled to receive a summary of their rights under the federal *Fair Credit Reporting Act* from a consumer reporting agency upon request to the agency.

I further certify that I have received and read a copy of the RULES AND REGULATIONS OF THE ARKANSAS STATE RACING COMMISSION GOVERNING GREYHOUND RACING IN ARKANSAS, and that I will observe and abide by such Rules and Regulations.
