## Public hearing on the following proposed rule changes:

<u>Thoroughbred Rule 1217.3</u> - This amendment to Rule 1217.3 sets additional guidelines for extracorporeal shock wave therapy.

Commissioner Steve Anthony made a motion to approve Rule 1217.3. Commissioner Steve Landers seconded the motion; Motion Passed.

Thoroughbred Rule 1218 - This amendment repeals sections (b)(1) and (2) of Rule 1218 as those sections conflict with the new HISA Rules, and the ARC is attempting to make its Rules comply with HISA before it is mandatory to do so.

Commissioner Steve Landers made a motion to approve Rule 1218. Commissioner Michael Post seconded the motion; Motion Passed.

<u>Thoroughbred Rule 1219</u>- This new rule lists prohibited practices outlined by the new HISA rules and is to adopt uniform rules consistent with HISA and other states before it is mandatory.

Commissioner Steve Anthony made a motion to approve Rule 1219. Commissioner Michael Post seconded the motion; Motion Passed.

<u>Thoroughbred Rule 2099.1</u>- Amends Rule 2099.1 to allow Stewards to grant 30- and 60-day extensions for horse owners / trainers to record timed workouts.

Commissioner Mark Lamberth made a motion to approve Rule 2099.1. Commissioner Alex Lieblong seconded the motion; Motion Passed.

<u>Thoroughbred Rule 2128A</u>- This new rule prohibits jockeys from using hand-held communication devices while on the racetrack.

Commissioner Michael Post made a motion to approve Rule 2128A. Commissioner Steve Anthony seconded the motion; Motion Passed.

<u>Thoroughbred Rule 2260</u>- Amends Rule 2260 to change purse distributions to include more horses.

Commissioner Mark Lamberth made a motion to approve Rule 2260. Commissioner Michael Post seconded the motion; Motion Passed.

<u>Thoroughbred Rule 2444</u>- Amends Rule 2444 to improve and clarify the claiming process for multiple claims in the same race.
