Internal Revenue Service (IRS) Scam Phone Calls



The IRS issued a consumer alert providing taxpayers with additional tips to protect themselves from telephone scam artists calling and pretending to be with the IRS.

These callers may demand money or may tell taxpayers they may

have a refund due and try to trick them into sharing private information. The callers may know a lot about the taxpayer, and they usually manipulate the caller ID to make it seem as though the call is actually from the IRS. The callers also use fake names and bogus IRS identification badge numbers. If a taxpayer does not answer the phone, the callers often leave an "urgent" callback request.

The IRS reminds people they can easily identify a fake IRS representative's call. Included in the following are five things a fake IRS representative will do that an actual IRS representative will not do:

- Call to demand immediate payment, nor will the IRS call about taxes owed without first mailing the taxpayer a bill.
- Demand payment of taxes without giving the taxpayer opportunity to question or appeal the amount.
- Require a specific payment method for taxes owed, such as a prepaid debit card.
- Ask for credit or debit card numbers over the phone.
- Threaten to bring in local police or other lawenforcement groups to have a taxpayer arrested for not paying.

If you receive a phone call from a suspected IRS scammer asking for money, please follow these tips:

- If you owe taxes or think you might owe, call the IRS at 1.800.829.1040. The IRS representative can assist you with a payment issue.
- If you don't owe taxes or have no reason to believe that you owe taxes, report the incident to the Treasury Inspector General for Tax Administration (TIGTA) at 1.800.366.4484 or at <u>www.tigta.gov</u>.

• You can file a complaint at the following link: <u>FTC</u> <u>Complaint Assistant</u>; choose "Other" and then "Imposter Scams." If the complaint involves someone impersonating the IRS, include the words "IRS Telephone Scam" in the notes.

Direct Deposit Refund Notices

DFA has been receiving many calls from taxpayers concerning direct deposit refund notices they are receiving in the mail.

The direct deposit refund notice looks like a check, but a disclaimer of "This is not a Check" is clearly written on the notice. If the bank account number listed on the notice is not the taxpayer's, they may have used a 3rd party such as H&R Block, Liberty Tax Service, and etc. to receive their refund.

The taxpayer needs to call their tax preparer if he or she receives a notice. Because depending on if a fee was charged by the tax preparer, the amount listed on the notice could be different than the amount in their bank account.

Please call the Income Tax Section at 501-682-1100 or 1-800-882-9275 for more information concerning direct deposit refund notices. If the Income Tax Section representatives view the ultimate bank account, they may be able to confirm the correct account for the taxpayer.

State Tax Filing-TurboTax

In a DFA press release dated February 6, 2015, Arkansas taxpayers were notified of taxpayers in other states who were experiencing a problem when attempting to use TurboTax to file their 2014 state income tax returns. These taxpayers received a message stating they had already filed a 2014 state tax return, even though the taxpayers had not filed their 2014 state tax return.

Per John Theis, Assistant Commissioner of Policy and Legal at DFA, in a February 9, 2015 KATV television interview, DFA is currently receiving and accepting returns from TurboTax, and DFA continues to run the TurboTax returns as well as all other electronically filed returns.

At this point, Mr. Theis stated there are no problems, and taxpayers can continue to use TurboTax to file Arkansas returns.

Rule 2015-1, Standard Mileage Rates for Income Tax Purposes

Rule 2015-1 has been promulgated to coordinate with a change in the allowable federal rate.

The rule sets the optional standard mileage rates effective January 1, 2015 through December 31, 2015, as follows:

- 1. For employees or self-employed individuals, the rate will increase by 1.5¢ from 56¢ to 57.5¢ per mile.
- For transportation expenses deductible as medical or moving expense, the rate will decrease by .5¢ from 23.5¢ to 23¢ per mile.
- 3. For charitable organizations, the rate will remain at 14¢ per mile.

Where's My Refund?

To make an inquiry on your Individual Income Tax refund status, you'll need to provide the following information as shown on your return:

- The social security number of the primary filer, shown as Your Social Security number on AR1000 or IRSIndividual Taxpayer Identification Number.
- The refund Amount expected from your AR1000.

Electronically filed refunds will generally be processed within 10 days of the time the acknowledgement is posted by the state. Please allow 6 weeks for your paper return to process. (Note: If your return is mailed back to you requesting a signature or additional information, or you are sent a letter requesting additional information, processing time begins after the state receives your additional information.)



It is a violation of State Law to make an inquiry or attempt to obtain information on another taxpayer.
