OFFICE OF SALES AND USE TAX ADMINISTRATION

Sales Tax Acts

<u>Act 465</u>: Provides for a phase-out of the InvestArk retention tax credit program for qualifying Arkansas manufacturers while providing a sales tax exemption for manufacturers on purchases of repair and replacement parts and services for manufacturing machinery and equipment. Repair, replacement, and modification parts and services being purchased for manufacturing *machinery* that is used directly by the manufacturer in producing, fabricating, manufacturing, assembling, processing, finishing, or packaging articles of commerce at their manufacturing facilities in Arkansas are eligible for this benefit. The Department will implement a new rebate procedure for Arkansas manufacturers who remit the sales tax utilizing their own sales and use tax forms for eligible repair, replacement and modification parts and services to their supplier at the time of purchase.

The phase-out will begin July 1st, 2018, the effective rates going forward are as follows:

- Effective July 1, 2018, the net tax rate would be 4.5%
- Effective July 1, 2019, the net tax rate would be 3.5%
- Effective July 1, 2020, the net tax rate would be 2.5%
- Effective July 1, 2021, the net tax rate would be 1.5%

• Effective July 1, 2022, the rate will be 0.0% and fully exempt from taxation.

Income Tax Rule

Revenue Rule 2018-1 "Standard Mileage Rates for Income Tax Purposes" was promulgated and adopted by the Department on May 15, 2018.

Explanation of rule:

The rule sets the optional standard mileage rates as follows:

- 1.) For employees or self-employed individuals, the rate will increase by 1 cent from 53.5 cents per mile to 54.5 cents per mile.
- 2.) For transportation expenses deductible as medical or moving expense, the rate will increase by 1 cent per mile from 17 cents per mile to 18 cents per mile.
- 3.) For charitable organizations, the rate will remain at 14 cents per mile.

Effective January 1, 2018 through December 31, 2018

OFFICE OF MOTOR VEHICLE ADMINISTRATION

Motor Vehicle Services

The Office of Motor Vehicle, the Office of Driver Services and the International Registration Plan (IRP) Office, began offering services online. All these services are available on the Department of Finance and Administration (DFA's) website at: mydmv.arkansas.gov

<u>Check Title Status Online</u> – This service will help tax payers to check the status of their application for title.

<u>Transfer Ownership</u> – This service will help tax payers to notify the Office of Motor Vehicles (OMV) if they have sold their vehicle to another individual or to a dealer.

<u>Print Duplicate Registration</u> – This service will help tax payers to print a duplicate registration online.

<u>Estimated Sales Tax Calculator</u> – This service will allow tax payers to calculate how much state tax they will owe for a vehicle before registration.

<u>Online Pre-Registration</u> – This service will allow tax payers to input specific Motor Vehicle details and receive a confirmation code for submission. The tax payer should present the confirmation code and necessary documents to their local State Revenue Office clerk to complete the transaction with minimal data input.

<u>Vehicle Registration -</u> This service will allow tax payers to register their vehicle online and "SKIP THE TRIP" to their local revenue office. User will enter Motor Vehicle details, pay sales tax, mail documents and obtain a confirmation code. The plate and registration will be mailed once documents have been received, reviewed and approved. Effective January 1, 2018

OFFICE OF DRIVER SERVICES

New Services

The Office of Driver Services began offering the following services online at <u>mydmv.arkansas.gov</u>:

<u>Change of Address Notification</u> – Arkansans may now update any change of address online. State law requires notification within 10 days of a change of address.

Arkansas State Revenue Tax Quarterly

<u>Pre-Registration for First Time License or ID Card</u> – This will allow those obtaining a first-time license or ID card the opportunity to pre-register online, reducing time spent in the Revenue Office.

<u>Update your renewal notice preferences to email or text</u>-Driver license and identification card renewal notices will no longer be mailed, but you may receive them by email or text by registering your preference online.

<u>**Request Records</u>** - Requests for records including a driver's license status/clearance letter and a license reinstatement requirements letter may now be performed online.</u>

<u>Enter Medical Information</u> - Commercial Drivers now have the opportunity to enter their required medical information online.

<u>Emergency Contact Information</u> - Arkansans may now update their emergency contact information online.

NEW DRIVER'S LICENSE AND STATE IDENTIFICATION CARD

The Arkansas Department of Finance and Administration (DFA) today announced a newly designed Arkansas driver's license and ID card will be issued beginning July 9 at certain Revenue Offices, with each of the 134 Revenue Offices throughout the state issuing the new card by August 28. The new card features distinctive Arkansas images. These include the gold front doors of the State Capitol along with diamonds. The back of the card features a full image of the State Capitol.

Existing licenses and cards, including those issued recently, remain effective through the expiration date. However, if Arkansans would like the new version, they may order a duplicate either in person at a Revenue Office or online at mydmv.arkansas.gov. The cost is ten dollars for a license and five dollars for an ID. Both are available online beginning July 9. "Arkansas Real IDs" are also eligible for a duplicate order either in person or online.

The new card incorporates innovative security features such as a "ghost image" in the lower right hand corner.

"Over the last three years DFA has prioritized the use of new technology to improve and simplify the services we provide to Arkansans," said DFA Director Larry Walther. "The new license is a great example of this effort. We incorporated new security features that protect citizens from fraud through duplication."

There were 2.15 million active Arkansas driver's licenses in 2017 along with more than 353,000 ID cards. Arkansas is a "one card state," allowing each citizen either one driver's license or ID card.

- Change a name on an account.
- Change an address on an account.
- Amend a return.
- Maintain all tax account types via a single login.
- Assign 3rd party logins (CPA, power of attorney, responsible party, & etc.).
- Store banking information for use during payment submission.
- Upload w-2 information.
- View tax period financial information (tax penalty, interest, credits, balance, & etc.).
- View payments received.
- View recent account activity.
- View correspondence from the department.
